Acceptance of the conditions

By filling out this reservation request, the applicant agrees to the unconditional acceptance of this contract.

For the smooth running of this event, any non-respect of this contract will see the applicant excluded from the show without a refund.

The stalls are assigned according to the order of arrival of the completed registration forms.

If the reserved stall is not occupied by the exhibitor by the time the show is open to the public, the space will be considered forfeited and the reservation cancelled. The stall will be reallocated by the organizers to another exhibitor without any compensation to the exhibitor who was originally awarded the space.

Payment of the stall

Every reservation request form needs to be accompanied by a cheque for the down payment of 50% of the stall rental fees, all taxes included. The cheque will be written to the order of: PARTNERS BAND MC.

Booking confirmation will be sent to you by mail upon reception of your completed application.

Stall rental fees

- Basic stall: €400 (3x2m), one brand, capable of welcoming one exhibitor (VAT non-applicable), 2 weekend passes.
- Double stall: €700 (6x2m), one brand (reserved for the exhibitors of the same shop), “ “ , 4 weekend passes.
- Triple stall: €1000 (9x2m), one brand (reserved for the exhibitors of the same shop), “ “ , 6 weekend passes.

Are included in the price for each option: one table, two chairs and an electrical outlet.

Payment terms

Space being limited the contract needs to be sent signed, with the deposit cheque, which will be cashed upon reception, at the following address: PARTNERS BAND MC – Chemin des iscles- 81 impasse des anges 83520 Roquebrune-Sur-Argens- France

The balance will need to be settled upon arrival on site.

Stall booking cancellation policy

The cancellation of all or part of the stall reserved by the exhibitor, by the present contract, needs to be done by registered mail, at least 3 months before the start of the show. Any later and the exhibitor will be accountable for the invoice of the stall.

If the stall is not occupied by the exhibitor by the time the show is open to the public, it will be considered that the exhibitor has cancelled his booking contract.

Internal regulations

The people named in the booking contract will be considered responsible for their stall.

They commit to respecting the venue and to not degrade, paint or nail the stall partitions. The same goes for the rest of the furniture made available.

The participants and exhibitors agree to photographs and videos being taken of them during the show and agree that these be used for free and non-exclusively.

No tattooing of anyone under the age of 18.

The use of audio systems in the stall is authorized as long as the noise cannot be heard in the neighboring stalls and that the sound be directed towards the exhibitor's stall.

It is forbidden to use materials that have not been fireproofed, M0 (combustible) or M1 (uninflammable).

All the equipment being used for demonstration need to include a safety system.

The distribution of leaflets, documents, objects or other is strictly forbidden outside of the stall.

A minimal amount of decoration is required by each exhibitor (banners, posters...) so as to present attractive stalls to our visitors.

The organizers will under no circumstances be held responsible for any theft that could take place inside or outside of the venue. Exhibitors are expected to have their own insurances.
